2025 Red Card information for Immigrants in the US

RED CARD: The red card is a two-sided wallet-sized card printed on a red background used to help immigrants in the U.S. regardless of their legal status. They provide helpful tips on what to do when encountering a U.S. Immigration and Customs Enforcement agent and to inform the card carrier of their constitutional rights.

Due to the increased demand for these cards, there is a shortage. If you do not have a red card, you can create a red card using the template below. Once printed, cut along the outside of the template and fold down the middle. Keep this in your wallet, or provide to any immigrants regardless of legal status.

 You have constitutional rights: DO NOT OPEN THE DOOR if an immigration agent is knocking on the door. DO NOT ANSWER ANY QUESTIONS from an immigration agent if they try to talk to you. You have the right to remain silent. DO NOT SIGN ANYTHING without first speaking to a lawyer. You have the right to speak with a lawyer. If you are outside of your home, ask the agent if you are free to leave and if they say yes, leave calmly. GIVE THIS CARD TO THE AGENT.
